Citing more than one work in the same citation	List the citations alphabetically by author, separated by a semicolon (;) ...as in recent studies (Hirst & Ferree, 1996; Tucker, 1994)	List each work separately in the reference list
Citing more than one work by the same author(s) in the same citation	List the author(s) once followed by the date of each work; separate the dates with commas Past research (Gumble, 2001, 2005) shows...	List each work separately in the reference list
Citing more than one work by the same author in the same year	Include the suffix (a, b, c etc) you added to the reference list According to NASA (2005b) Several studies (NASA 2005a, 2005b) show...	Add a suffix "a, b, c" etc to the date of each work based on the order they appear in the reference list (alphabetically by title) NASA. (2005a). <i>NASA sets sights on Pluto</i> . Item from a course book	Give the author and date of publication and page number (Ross, 2009, pp. 23-45)	List as a publication of limited circulation Ross, J. (2009). <i>RECN 110 Concepts in Sport and Recreation reading resource book</i> . [Available from Lincoln University to enrolled students.]
Item posted on course Learn site	Give the author and date (Bowring, 2009)	List as an item of limited circulation Bowring, J. (2009). <i>Otahuna images in pictures</i> [PowerPoint slides]. [Available from Lincoln University Learn@Lincoln LASC 316 Web site.]

Web pages and online items

- All items retrieved online use the same basic format with extra information included as necessary.
- Each individual page you use information from must have its own reference list entry.

NOTE: When determining the date of a web document DO NOT use the copyright date in the footer of the website as this date does probably does not correspond to the specific page you are viewing.		
Including a retrieval date A retrieval date is not required but can be added if you wish.	Give author and creation/update year ...according to government sites (Ministry of Justice, 2012) we see...	List the author. (date of publication). Title Retrieved date from URL Ministry of Justice. (2012, April). <i>Asians in the justice system</i> . Online documents such as PDFs and Word documents	Give author and creation/update year. ... water deaths in New Zealand (Dyson, 2005).	List as a web page using the unique address that takes you directly to the document Dyson, R. (2005). <i>Drowning prevention strategy: Towards a water safe New Zealand 2005-2015</i> . Online document such as PDF or word document with no unique address	Give author and creation/update year Government accounting figures (Statistics New Zealand, n.d.) tell us... Blog entry If the author uses a screen name or handle use that as the name element. Online video e.g. YouTube	Give the author (which may be a screen name) and creation year ...which Norton (2006) claims proves cats are untrainable.	List as a web page giving a specific date of posting and add [Video file] after the title Norton, R. (2006, November 40). <i>How to train a cat to operate a light switch</i> [Video file]. Retrieved from http://www.youtube.com/watch?v=Vja83KLQXZs
Entire web site	Do not include in the reference list. You may mention the whole site in your text. Each page referred to must be individually cited and included in the reference list.

The Reference List

- The reference list is placed on a new page under the heading “References”.
- Only items cited in text are included in the reference list. Works you have not identified in the text are not included.
- The reference list is double-spaced and listed in alphabetical order according to the first author’s name. Works by the same author(s) are listed in order by date of publication with the oldest listed first.
- The second and later lines of each reference are indented by 5 characters.
- If a web address wraps across 2 or more lines, break it before a punctuation mark such as ? / or #
- Make sure that Word does not underline hyperlinks.
- If your reference ends with a URL (Web address) do not add a final full stop.
